**Balance is due 30 days prior to arrival.** It is payable to Historic Hideaways, Inc. in the form of **cash, traveler's checks, cashier's check, MasterCard, Visa, Amex, personal check or business check.** You must contact our office no later than **30 days prior to arrival to make arrangements to pay your final balance.**

Check in is accomplished at the office, 1109 Duval Street, Key West, Florida. Check in time is between 2 p.m. and 5 p.m. **Guests arriving between 5 p.m. and 11 p.m. will be charged a \$25.00 check in fee and must contact this office 48 hours prior to arrival to make check-in arrangements. THERE WILL BE NO CHECK-INS AFTER 11 P.M. Office is closed Sunday, therefore please call our office 48 hours prior to arrival to arrange Check-in. CHECK OUT TIME IS BY 11 A.M.**

**Cancellation Policy:** Guest's deposits will be non-refundable less than 60 days prior to arrival. Up to 60 days prior to your arrival date, your deposit is refundable less a \$250.00 cancellation fee. Travel Insurance fees are non-refundable at all times. Holiday and special event bookings may have higher cancellation fees.

A security deposit of **\$500.00** in cash or a *signed and authorized VISA, MASTERCARD or AMEX* voucher will also be required from the guest(s) at check-in. After receiving all bill(s) covering the time of the rental period, owner/agent will return guest's deposit less any damages or excessive cleaning. **PLEASE BE ADVISED THIS MAY TAKE UP TO 60 DAYS.**

Guest(s) shall take good care of premises, appliances and furnishings. Guest(s) shall also be responsible for all conditions and damages caused by the neglect or wrongful act or omission of the guest(s) and/or persons accompanying guest.

If the guest(s) defaults in the performance of any of the obligations contained herein, the Owner/Agent shall be entitled to recover all costs and expenses as well as court costs and reasonable attorney's fees. In the event of default, guest will be liable for a \$75.00 processing fee, payable to Agent immediately when default is disclosed or discovered.

Cleaning: Unit will be cleaned after departure with no additional charges **if the unit is left in "as found condition."** Guest shall be responsible for excessive cleaning charges. See enclosed rules and procedure sheet.

No pets shall be permitted, unless prior arrangements have been made.

No refunds will be given for situations out of the control of Historic Hideaways, Inc. These include, but are not limited to: government actions, adverse weather or beach conditions or road/building construction that may occur around or near any of our properties or in Key West. Historic Hideaways, Inc. and an authorized employee or repairmen may enter the premises during normal business hours for any purpose pertaining to repair, improvement, care and management of the property.

The Renter agrees that Historic Hideaways shall not be liable to Guest, Guest's guests, invitees or any other person for any loss, theft or personal injuries or casualties sustained to any person or property on or about the rental premises.
